Trade Marks

A Trade Mark is any sign which can distinguish the goods or services of one trader from those of another. Words, logos, pictures or a combination of both can be used to create a distinctive mark which can be registered and protected for your use in the future.

Trade Marks are used to protect your company identity and to prevent the unauthorised use of a words, logos or other distinctive marks which are synonymous with your business.

Our Trade Mark registration services involve the following steps:

- Discussing your Trade Mark registration requirements in detail with you and gaining an understanding of the Trade Mark that you wish to register as well as gaining an understanding of your business and the sector that you are trading in.
- Establishing the class in which your Trade Mark should be registered to offer the best possible protection to your business identity.
- Carrying out a detailed search to establish whether the mark that you wish to use is available and not already in use by another party and establishing whether a Trade Mark which is very similar to the one you wish to register already exists or not.
- Registering your chosen Trade Mark in the appropriate classes with the Patent office.
